### 3..Vaccinations

All teachers are encouraged to vaccinate as soon as possible. However, we recognize there may be extenuating circumstances for some of us. Vaccinations are not mandatory.

We have received numerous inquiries on vaccinations and subsequent ADA accommodations. These accommodations are based on the doctor's assessment of the health situation of their respective patient (teachers in this case). HR will not unilaterally and arbitrarily remove the accommodation because a teacher is now vaccinated. Each ADA accommodation is handled on a case by case basis, both for initial approval and moving forward. Physicians might suggest an update as to the need for an ADA accommodation based on any new medical information. Vaccinations may or may not have anything to do with the accommodation in place. That is a medical decision for each respective physician.

# 4.FFCRA (Families First Corona Response Act)

The federal law providing  $\frac{2}{3}$  pay for up to 80 hours (2 weeks) expired on December 31st. Various state governors have chosen to extend this federal law in their respective states through April 20th. CT is a participating state. Therefore, teachers can still access any remaining time from the original 2 weeks (80 hours) that was unused prior to Dec 31, 2020.
